Our Mission:

Parkinson Canada's mission is to transform the lives of People Living with Parkinson's through: **RESEARCH** leading to the end of Parkinson's, **ADVOCACY** bringing the voices of Parkinson's to the forefront and **SUPPORT** helping people living with Parkinson's live well through education and services.

What We Need:

Parkinson Canada is looking for leadership volunteers across Canada who demonstrate excellence in their field of expertise and who possess a strong mix of leadership skills, care, and vision critical to due diligence and good governance. Emphasis will be on recruitment of candidates who have the time and experience to make a significant impact on the long-term performance of Parkinson Canada.

Time Commitment:

- 1-2 teleconference Board meetings; and
- Participation on a minimum of one Board committee

Selection Process:

- All applicants must submit a letter of interest, a completed Board Director Application form, and a resume. Selected applicants will be contacted by the Governance and Nominating Committee to arrange an interview.
- All other applicants will be informed about the outcome of the selection process by May 8, 2019.
- Elections for the Board of Directors will take place at the Parkinson Canada Annual General Meeting of Members on Friday, June 14, 2019, in Toronto, Ontario.
